

THE TJX CANADA CUSTOMER EXPERIENCE SURVEY SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

ALL DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION AND ENTRANTS WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT.

SWEEPSTAKES ENTRY PERIOD: The **TJX Canada Customer Experience Survey Sweepstakes** (the "Sweepstakes") begins at 12:00:01 AM Eastern Time ("ET") on Thursday, July 29, 2021 and ends at 11:59:59 PM ET on Sunday, July 31, 2022 (the "Sweepstakes Period").

ELIGIBILITY: The Sweepstakes is open to legal residents of Canada who are the age of majority in his/her province of residence or older at the time of entry. Void outside Canada and wherever else prohibited by law. Employees of TJX Canada (the "Sponsor"), InMoment, Inc. (the Survey Administrator), US Sweepstakes & Fulfillment Company (the "Sweepstakes Administrator") and their respective subsidiaries, affiliates, advertising and promotion agencies, and the immediate family members (spouses, parents, children, and siblings and their spouses) of, and/or those living in the same household of each, are not eligible to enter. Sweepstakes is subject to all applicable federal, state, provincial and local laws and regulations.

HOW TO ENTER: There are two (2) ways to enter.

Method #1: Receipt Invite - To enter visit the website located on your specially marked TJX Canada receipt received from the participating TJX Canada locations, enter the required information located on your receipt (the "Receipt Information"), and answer any required survey questions including Entrant's contact information. Entrants must follow online instructions at the designated website for entering Receipt Information. When the Receipt Information has been successfully entered and accepted (Receipt Information must be entered exactly as they appear or they may not be accepted), Entrants will be invited to complete a survey. The answers to the survey will have no effect on an Entrant's ability to enter or win. Upon completion of the survey, the Entrant will be invited to complete the Sweepstakes entry form in its entirety and submit to receive one (1) Sweepstakes entry (the "Survey Entry") during the Survey Period (as defined below) in which the entry is received. Each Receipt Information may only be entered one (1) time during the Sweepstakes Period and cannot be re-used. All information received becomes the property of the Sponsor and will not be sold to any third party. Proof of entry does not constitute proof of submission. All Receipt Information is subject to verification. Online Entrants are subject to all notices posted online including but not limited to the Sponsor's Privacy Policy. There is no limit to the number of receipt invite entries an Entrant can receive.

Method #2: Free, Alternate Method of Entry ("AMOE") / Mail-in Entry. To enter without purchase, mail a postcard (the "Mail-In Entry"), including your full name, complete mailing address, email address and phone number to US Sweepstakes & Fulfillment, ATTN: The TJX Canada Customer Experience Survey, 17-7000 McLeod Road, Unit 135, Niagara Falls, ON L2G 7K3. Mailed entries must be postmarked by the Entry Period End Date and received by the date

indicated in the chart below, to be eligible for the corresponding monthly Survey Period drawing. Each mail-in entry must be mailed in a separate outer envelope. No copies, facsimiles or mechanical reproductions will be accepted. Limit one (1) mail-in entry per post-marked envelope. Partially completed and/or mechanically reproduced entries or rubber-stamped entries will be void and ineligible. All entries received become the sole property of Sponsor and will not be returned. Sponsor will not be responsible for illegible, incomplete, late, lost, mutilated, misdirected, postage due or stolen manual entries.

Survey Entry and Mail-In Entry collectively referred to herein as “Entry” or “Entries”. Limit: One (1) entry (i) per Entrant or (ii) per Entrant’s email address per week regardless of methods of entry. If more than one entry is received from the same person or email address in the same week, all but the first entry will be disqualified. Total value of all prizes available to be won: \$18,000.00 CAD. Limit: One (1) prize per person/household during a Survey Period.

Odds of winning a prize will depend upon the total number of eligible entries received for each Survey Period.

RANDOM DRAWING: The winners will be selected in a random drawing at 1:00 PM ET per the drawing date indicated in the chart above from among all eligible entries received during the Sweepstakes Period. The random drawing will be conducted by the Sweepstakes Administrator in Rochester, New York.

WINNER NOTIFICATION & VERIFICATION:

Grand Prize: Potential Grand Prize winner will be notified via email and/or phone, and will be required to confirm his/her mailing address and correctly answer a skill-based mathematical test question without mechanical or other aid (which may, in the sole and absolute discretion of the Sponsor, be administered online, by email or other electronic means, by telephone, or in the Sponsor's form of Declaration and Release) within a limited time-period in order to be eligible to receive his or her prize.
